The winter session of the Manipur Legislative Assembly has once again unanimously passes the Bill on 21st Dec 2018. The Manipur International University Act, 2018 (Manipur Act No.2 of 2019) has received the final assent of the Hon'ble Governor of Manipur on 23rd Jan, 2019 and it has been notified by the Law and Legislative Affairs Department, State Government of Manipur in the official Gazette Extraordinary of Manipur State on 14th Feb, 2019. The University is fully recognised by UGC under section 2(f) of UGC act 1956 and Institutionally accredited by the State Government of Manipur via the MIU Act, 2018.







# MINIMUM REQUIREMENTS TO BE FULFILLED BY THE RESEARCH SCHOLARS FOR CONFERMENT OF A POST- DOCTORAL DEGREE

1. Publication of At least 4 Review Papers and 6 Research Papers to be published in any reputed peer-reviewed indexed journal as First Author or Corresponding Author. All the papers should be related to the subject of post-Doctoral research. Author Affiliation should bear the name of both institutions. The first one being the institution presently working and the second one being the Manipur International University.

2. The respective Universities will issue the certificate through the Coursera platform, and the University shall issue a separate transcript with course credit at the end.

3. Submission and approval of Synopsis.

4. PowerPoint presentation, Viva-voce and Défence of the thesis.

5. Submission and approval of post-Doctoral thesis with written recommendation on thesis and for conferment of a post-doctoral degree from the Mentor and two external examiners.




# Selection Process Details:

The Entrance Test shall be of one and half hour duration (i.e. 90 minutes) and of 100 marks consisting of 100 objective type of questions.


